## **Services:**

Keelyn N. Barrick provides a number of psychotherapeutic services which include but are not limited to:

- Individual Therapy involving adjustment to changes encountered during the life cycle development
- Marriage/Couples Therapy involving adjustment to changes encountered during the life cycle of a relationship.
- Family Therapy involving adjustment to changes encountered by the family life cycle.
- Therapeutic assessment and treatment of Posttraumatic Stress Disorder in individuals, couples, or families.



## **Fees:**

It is customary to pay for professional services at the time they are rendered. The hourly fee for individual therapy is \$90 per hour and for couples and families is \$120 per hour. Group therapy and workshop fees will be determined. Keelyn N. Barrick accepts cash, check, debit or credit card. She does not accept insurance at this time, however a receipt for services can be obtained for you to submit for reimbursement on your own.

## **Confidentiality:**

The information you share in psychotherapy is protected health information and is generally considered confidential by both South Carolina statute law and federal regulations. Your therapy file can be subpoenaed in South Carolina through a court order (signed by a judge) but is considered privileged in the federal court system. Keelyn N. Barrick is mandated by standards - through Duties to Warn - to breach confidentiality if she discovers:

- 1) you are threatening self-harm or suicide
- 2) you are threatening to harm another or homicide
- 3) a child has been or is being abused or neglected, and/or
- 4) a vulnerable adult has been or is being abused or neglected.

In addition, if you wish your protected health information released to another party, you *must* sign a specific Release of Information.
